ORDER PLACING DEFENDANT ON MISDEMEANOR PROBATION

THE COURT, THIS 30th DAY OF May 2023 HEREBY ORDERS YOU SHALL BE PLACED ON PROBATION FOR A PERIOD OF SIX (6) months, under the supervision of the Jacksonville Sheriff's Office. You shall comply with the following conditions of probation:

1. You will pay applicable probation fees while under supervision to include: \$60.00 monthly supervision, daily fees if you have a varying type of electronic monitor on, urinalysis fees, mandated class fees, and a fee if you fall into violation status. The fee schedule can be found at: <https://www.jaxsheriff.org/Resources/fees.aspx>.
2. You will pay applicable court costs and restitution costs through the Clerk of Court's office, as well as provide proof of said payment to your assigned counselor.
3. You shall not change your residence or employment without consent of your counselor. You will allow the Jacksonville Sheriff's Office to visit your home and/or employer while under supervision.
4. You will make a full and truthful report to your counselor once per month or as otherwise directed by your assigned counselor. You will answer your counselor's questions truthfully.
5. You will remain at liberty without violating any law. A conviction in a court of law shall not be required to constitute a violation of your probation.
6. You will not use intoxicants to excess; nor will you visit places where illegal drugs or other dangerous substances are sold, dispensed, or used.
7. You will work diligently at a lawful occupation and support any dependents to the best of your ability.
8. You will neither possess nor carry any weapon or firearm while on probation without the consent of your counselor.

Additional probation requirements: At least 10 hours

- Community Service Hours: 50 Per month
- Vehicle Immobilization (in days): 10
- No Victim Contact: _____
- Batterers' Intervention Class
- Early termination of probation upon completion of conditions (Eligible only, requires approval from judge)

- DUI SCHOOL: (EVE) 1 LEVEL 2 (CIRCLE ONE) Enroll w/in 20 days
- Victim Impact Panel Class
- Substance Abuse Evaluation & Applicable Treatment
- Mental Health Evaluation & Applicable Treatment
